(6) That Aaron Bell, Chris Bryant, Jackie Doyle-Price, Ms Angela Eagle, Maria Eagle, Peter Gibson, Mr Robert Goodwill, David Linden, Alan Mak, Mrs Maria Miller, John Spellar, Alexander Stafford, Mr Shailesh Vara and Craig Whittaker be members of the Committee.
