For 60-minute and 90-minute debates, there will be a call list. Only Members on the call list will be called to speak, and they will be generally called in the order they appear on the call list, subject to discretion of the Chair. Members will be called in the order they appear on the call list.

Members who are not on the call list are permitted to attend debates provided that they do not take a place on the horseshoe which would prevent a Member on the call list having access to the horseshoe. Members not on the call list may attend to listen to debates or intervene, but will not be called to give a speech. Members must make interventions from the horseshoe and not the public gallery (see arrangements for social distancing below).

For 30-minute debates, there will not be a call list. Members may attend to intervene or make a speech. Members wishing to make a short speech should follow existing conventions about contacting the Member in charge of the debate, the Speaker's Office and the Minister.
