Question agreed to.

## 8 United Kingdom Internal Market Bill: Reasons Committee

Paul Scully reported that the Committee had agreed the following Reasons:

Lords Amendments 1B, 1C and 1D

Because the Lords Amendments will create legal uncertainty, which would be disruptive to business.

Lords Amendments 14 and 52 to 54

Because the Lords Amendments (together with Lords Amendment 55 which has been agreed by both Houses) were only made in consequence of the omission of Part 5 of the Bill by Lords Amendments 42 to 47 and

so have become unnecessary following the Lords' non-insistence on Lords Amendments 42, 43 and 46.

Lords Amendments 48B and 48C

Because the Lords Amendments would alter financial arrangements made by the Commons, and the Commons do not offer any further Reason, trusting that this Reason may be deemed sufficient.

Lords Amendment 50C

Because, while the Commons agree to Lords Amendment 50B, it is not appropriate to link the operation of the reservations proposed by clause 50 to Common Frameworks.

The Reasons were agreed to.
