1304 East Lothian village school pupils tackle speeding

That this House recognises the great community effort by Saltoun Primary School pupils in helping to tackle speeding in the village of East Saltoun in East Lothian; notes that those pupils joined forces with community police officers and slowed down speeding cars to ask them a number of set questions as to why they were speeding in an effort to help influence drivers behaviour; understands that those pupils waved down vehicles and were set up beside the school and village hall alongside their teachers and the police; further notes that the police officers ensured that drivers not complying with the 20 mph limit were invited to speak to pupils and that both drivers and pupils were educated on road safety; remarks that that action will surely help those drivers think twice and abide by the speed limit when next driving through East Saltoun and other rural villages; and thanks the pupils, police and Saltoun Primary School staff for their efforts in raising awareness and taking action on rural speeding.

1305 Holocaust Memorial Day 2021

That this House notes that on 27 January 2021 the UK will observe Holocaust Memorial Day marking the anniversary of the liberation of Auschwitz-Birkenau, where an estimated 1.1 million people were murdered; commemorates the six million victims of the Holocaust; further notes that the theme for Holocaust Memorial Day 2021 is Be the Light in the Darkness; pays tribute to the commitment of Holocaust survivors and Kindertransport refugees who share their experiences with young people across the country; acknowledges the importance of the Holocaust Educational Trust's work in schools across the UK and in particular the Lessons from Auschwitz project, which has so far given more than 40,000 students and teachers the opportunity to visit Auschwitz-Birkenau; welcomes the establishment of a permanent National Holocaust Memorial and Learning Centre adjacent to Parliament; pays tribute to the Holocaust Memorial Day Trust for organising the national Holocaust Memorial Day event; and urges all right hon. and hon. Members to observe that day so that the appalling events of the Holocaust are always understood by future generations.

1306 Education of children living in homes where someone is clinically extremely vulnerable during the covid-19 outbreak

That this House recognises Government guidance states, Children who live with someone who is clinically extremely vulnerable, but who are not clinically extremely vulnerable themselves, should still attend school; notes that hon. Members cannot underestimate the profound psychological impact that it would have on a child to go to school, come home with covid-19 and infect a family member and for that family member to then die; further notes that for a child to feel that the death of a family member was their fault would be traumatic in the extreme; regrets that the Government does not hold information centrally on the number of school pupils who live in a household with someone who is clinically extremely vulnerable; notes that the Association of Directors of Children's Services estimates that the number of children withdrawn from school for elective home education increased by 38 per cent in England in 2020 and that feedback from responding local authorities to their research indicated that covid-19 health concerns were a primary reason for parents or carers choosing to formally home educate their child in 2020; calls on the Government to bring forward guidance to ensure that children who live in a household where someone is clinically extremely vulnerable are able to learn from home during the covid-19 pandemic if that is what their parents or carers think is best; and further calls on the Government to provide the necessary financial support to schools so that head teachers can facilitate that home learning without having to worry about resource implications.

1307 Touring artists after UK's departure from the EU

That this House notes that 2 January 2021 will be the 50th anniversary of the Ibrox disaster which killed 66 people and injured over 200 people; notes that this was the worst football disaster in Britain until the Hillsborough disaster in 1989; notes that all 66 who died on 2 January 1971 were aged under 50 years of age, including five schoolmates from the town of Markinch in Fife; remembers all those who died and expresses continued sympathies and prayers with the families who lost loved ones; and further notes that the disaster is commemorated with a statue at Ibrox stadium; recognises the major changes to football stadia design and standards and that spectator safety is always paramount in enjoying sport.

1311 EU ban on Scottish seed potato exports

That this House notes with dismay the damaging effect that the UK leaving the EU is set to have on Scotland's vital seed potato sector by virtue of the UK's trade deal with the EU; understands that conventionally around 22,000 tonnes of Scottish seed potatoes, which are highly regarded internationally for their high plant health status, are exported to the EU and Northern Ireland each year; regrets that from 1 January 2021 Scottish seed potatoes will be banned from being exported to the EU and Northern Ireland; further notes that Scotland accounts for 75 per cent of UK seed potato production and 80 per cent of exports; and calls on the Department for Environment, Food and Rural Affairs to urgently provide support for that vital sector.

1312 EU visa system for touring artists and musicians

That this House notes with concern that while the deal agreed between the UK and the EU provides exemptions to visa rules for certain workers travelling to different European countries, this does not include artists and musicians; understands this will result in artists having to apply for separate visas for each individual country visited while touring in Europe resulting in significant added cost; further notes that the petition launched by artist Tim Brennan on that matter has exceeded the 100,000 signatures needed to secure a debate in the House; and urges the UK Government to urgently introduce a visa for touring musicians and other artists to facilitate their work across Europe without requiring the need for multiple visas and attendant additional costs.

1313 Scottish fishing and the effects of the UK-EU Trade and Co-operation Agreement

That this House notes that the UK-EU Trade and Co-operation Agreement ties UK fishing fleets into a continuing Common Fisheries Policy with quotas of total allowable catch being allocated through agreement with the EU which will mean decreasing allowable catches for Scottish boats; further notes that any termination of the fishing heading will also terminate the agreements on trade, aviation and transport under FISH17; considers that fishing communities will consider this a betrayal and that the promised Seas of Opportunity have become lost opportunities; and calls on the Government to address the concerns of the Scottish fishing industry on fishing quotas.

1293 **GenOMICC consortium**

That this House commends Midlothian-based researchers for the role they have played in identifying potential covid-19 treatments as part of the the GenOMICC consortium; further commends all involved in the consortium; notes that this work has led to the discovery of five genes associated with the most severe form of covid-19 by studying the DNA of 2,700 patients in 208 intensive care units in the UK; understands that this work was carried out by researchers from the GenOMICC consortium, a global collaboration to study genetics in critical illness; further understands that the research compared the genetic information of covid-19 patients in ICU with samples provided by healthy volunteers from other studies, such as UK Biobank, Generation Scotland and 100,000 Genomes; and notes that, through institutions such as the Roslin Institute, Midlothian plays a key role in leading scientific research.

1301 Expansion of Heathrow airport

That this House is disappointed by the decision of the Supreme Court to rule in favour of Heathrow airport's appeal to the decision in February 2020 that the Airports National Policy Statement was not legal because it had been written using a warming target of 2 rather than the Paris Agreement target, signed by the UK, of 1.5; notes that a third runway at Heathrow would increase takeoffs from 2030 onwards by 54%, which would increase air and noise pollution and impact the mental and physical well-being of millions in the surrounding area; recognises that an expansion would increase carbon emissions as well as the harmful contribution of aviation to other forms of global warming; notes that projections continue to show that the Government is unlikely to reach their 2050 net zero targets; further notes that the international community is also currently unlikely to reach the 1.5 warming target as recognised in the Paris Agreement; calls on the Government

to update aviation policy to meet its target for net zero carbon by 2050; and further calls on the Government to eliminate any possibility of net expansion to UK airports including Heathrow in line with guidance from the Committee on Climate Change.

1302 Stay Connected project Coatbridge
