That this house is alarmed by reports from Sri Lanka of a systematic attack on democratic governance, the rule of law and human rights including renewed threats of violence against the Tamil and Muslim communities; is profoundly concerned that the Sri Lankan Government has refused to investigate credible accusations of war crimes including by key members of the current Government and has withdrawn from the UN Human Rights Council Resolution 30/1 calling for the Promotion of reconciliation, accountability and human rights which formally ends in March 2021; welcomes the significant leadership role played by successive UK Governments at the Human Rights Council and urges the present Government to provide timely and clear policy direction and leadership to ensure a new substantive resolution is passed at the upcoming HRC session in March 2021 that will ensure

continued monitoring by the Office of the High Commissioner for Human Rights and mandate a mechanism to gather, preserve and analyse evidence of violations for future investigations and prosecutions thereby building on extensive work already completed by UN investigators and exploring options for additional action by the international community; and calls upon the Government to develop a consistent and coherent policy to address the concerns outlined above through its trade, investment and aid programmes, and in its diplomatic and military relations.
