That this House understands concerns that the Stort crossing proposals will have on the beautiful environment of the Stort Valley in Harlow constituency; further understands the threat that those proposals pose to local wildlife and ecosystems; recognises the concerns on those proposals raised by hundreds of local residents; further recognises that the plans for that problematic development have been inherited from the previous Labour Council who agreed to the proposals in the 2020 Local Plan; notes that Harlow Conservative Councillors voted against the 2020 Local Plan; further notes the upcoming Planning Committee meetings of both East Herts Council and Harlow District Council at which this planning application will be considered; and calls on the Government to put pressure onto the developers to reassess those plans and go back to the drawing board.

That this House notes the pre-covid-19 outbreak changes to funding for adult social care council budgets since 2010; recognises local Government as the primary commissioners of adult social care services; notes with concern the absence of local Government as part of the Government's announcements on social care reforms and delivery; further notes that the £5.4 billion assigned to adult social care out of the £36 billion to be raised over three years following the introduction of the Health and Social Care levy is not adequate to match the scale of the issues facing that sector; notes that the statement made by the Prime Minister of 7 September 2021 is a plan predominately to assist the NHS and not the broken adult social care sector; asserts the Government has not addressed the job retention and vacancy problem facing the adult social care sector by improving

pay, terms and conditions as well training opportunities for the care workforce; recognises the inability of the market to provide the solutions to underoccupancy in care homes and the sharply increasing demand for home care services; and agrees with the calls of Age UK to provide a big injection of funding to councils' care budgets which includes a social care workforce strategy to meet rising demand and the needs of disabled and older people by widening the criteria for state support alongside a new deal for unpaid, informal carers.

That this House opposes the planned staging of the AOC Europe 2021 electronic warfare event, organised by Clarion Defence and Security, at Liverpool's Arena and Convention Centre (ACC) in October 2021; notes that that event will bring together many of the biggest global arms companies with government and military officials attending from across the world; further notes that that event will showcase and display a wide range of armaments and military equipment; notes that such military equipment being showcased has been used, and continues to be used, by regimes that have abused human rights and civil liberties; recognises that the use of such military equipment inevitably exacerbates the potential for conflict and undermines the search for peaceful solutions to international problems; further recognises that communities in Liverpool have proudly stood with those suffering injustice for many years and agrees that the staging of that event is an affront to the city's shared values; calls on ACC Liverpool Group to reconsider hosting that event, and any future events, which undermine the city's commitment to peace and human rights; and urges ACC Liverpool Group to work with Liverpool City Council to develop and adopt an ethical charter as company policy.

That this House recognises that species-rich grasslands offer ways of reducing the impact of greenhouse gases that cause climate change by reducing flooding risk, locking up pollutants and acting as critical ecosystems for pollinators and supporting sustainable and resilient farming; regrets that in the last 100 years the UK alone has lost 97 per cent of its meadows and other species-rich grasslands leading to bumblebee extinctions and butterfly population declines; welcomes the formation of Grasslands+, a growing coalition that has come together to protect and restore the planet's grasslands, savannahs, plains, heaths, steppes and meadows; urges Government Ministers to use the opportunity of COP26 in Glasgow to seek international recognition and protections for species-rich grasslands, to lead by example in taking action to mitigate the effects of climate change and increase biodiversity and to ensure that those areas of natural beauty are preserved for future generations to enjoy.

337 Spyware and state surveillance of journalists

That this House is deeply concerned by reports that at least 180 journalists across the world have been spied on using Pegasus software, a tool developed by the Israeli cybersurveillance company NSO and sold to a number of clients, including states across the world; notes that among those who have been the targets of the global spying operations are human rights defenders, political opponents, lawyers, diplomats and heads of state; further notes that the list of the 180 journalists targeted includes reporters from global media platforms, as well as freelance investigators who appear to have been targeted by regimes determined to uncover sources, undermine research, and in some cases, stop their reporting; believes that those revelations of the use of NSO's Pegasus software to spy on journalists shows the profound vulnerability of media freedom and illustrates the serious breach of the public's right to know; and therefore joins the National Union of Journalists in the UK and Ireland and the International Federation of Journalists in utterly condemning all attempts to interfere with journalists' private communications, encouraging journalists to use extra vigilance to protect their data and calling on governments to enshrine in domestic law the inviolability of journalists' communications.

341 The Death of Father Stan Swamy

That this House welcomes the imminent publication of the report by the Truth, Reconciliation and Reparations Commission of the Gambia, following publicly televised testimony for over two years from victims and former officials, including members of an elite death squad, implicating former Gambian President Yahya Jammeh in the killing and torture of political opponents, the murder of almost 60 West African migrants, the rape and sexual assault of women and a sham HIV treatment programme resulting in over 30 deaths; hopes the report recommendations will be implemented, and the criminal prosecution of Jammeh and his main accomplices will follow; notes that since the end of Jammeh's brutal 22 year dictatorship in 2017, progress in restoring fundamental rights has yet to be consolidated, for instance by ensuring future elections are free and fair and the harassment of journalists and other civil society representatives by the security forces ended; regrets current Gambian President Adama Barrow did not step down as originally agreed with the coalition that backed him and that corruption, female genital mutilation and child marriage remain serious problems; applauds the imposition of sanctions by the UK Government and others on former Gambian President Jammeh, his wife and the former director-general of the country's National Intelligence Agency; and calls on the Government to continue supporting the Gambia's democratic transition, to assist with implementing the report recommendations and to back the criminal prosecution of Jammeh and others responsible for gross abuses there.

That this House urges the Government to review its nuclear policy; notes that Dungeness Power Station stopped generating in June 2021, seven years early due to safety concerns; that Hunterston B will stop generating in 2021, Hinkley B in 2022, Hartlepool and Heysham Power Stations in 2024, that Torness and Heysham 2 will close before their 2030 target; further notes that Hinkley Point C being constructed has suffered cost and programme overruns with the predicted commissioning date of unit one revised to June 2026 with an additional programme risk of a further 15 months, meaning unit one might not generate until 2027 and unit two in 2028, years after the majority of the existing fleet is offline, proving that the need for nuclear baseload generation is an outdated concept; notes that the Hinkley £92.50per MWh strike rate over a 35 year contract period compares badly to the offshore wind strike rate of £40MWh for a 15 year contract; further notes that under the existing grid charging regime, EDF will be paid money to connect to the grid, while Scottish renewable energy projects pay the highest grid connection charges in Europe; draws attention to the report by Good Energy and Energy Catapult Systems that shows net zero can be reached without new nuclear projects; notes that the reliance on China General Nuclear is a mistake; and calls on the Government to scrap its intention to build new nuclear power stations and avoid adding to the nuclear waste legacy estimated to cost £132 billion.
