# **New EDMs**

#### 445 Palliative care

#### Siobhain McDonagh

That this House notes with concern a recent report by Marie Curie which predicts a 42 per cent increase in demand for end-of-life care by 2040; acknowledges the lack of funding for palliative care in the UK; recognises the crucial role end-of-life care has played during the covid-19 pandemic; understands that palliative care services are under significant strain and as a result almost 15,000 people have died outside of hospital without the necessary support during the covid-19 outbreak; further recognises the continual increase in cost to provide these vital services; and therefore calls on the Government to bring forward plans to this House that resolves the social care crisis and provides sustainable funding for the palliative care sector.

# 446 Broadband for the Rural North campaign

That this House commends Broadband for the Rural North's (B4RN) non-profit, community-led approach to developing Fibre To the Premises (FTTP) networks, which has connected 9000 properties across Cumbria, Lancashire and Northumberland; notes the Government's intention to deliver a minimum of 85 per cent gigabit-capable coverage across the UK by 2025 through Project Gigabit; realises that the model of community-led ISPs, such as B4RN, do not fit with the conditions placed upon Regional and Local suppliers through Project Gigabit; further notes that the deadline for individuals to register for the Voucher Scheme is 24th September 2021; and calls on the Government to ensure the future of Community Benefit Society ISPs by moving areas where they are already actively engaged into Conditional White procurement categories.

# 447 Kirkcaldy Strong group's community walk

That this House congratulates community fundraising group Kirkcaldy Strong on successfully completing their community walk on 11th September; understands that their route took them via various local charities for whom they were raising funds, including Nourish Support Centre, Kirkcaldy Samaritans, Greener Kirkcaldy, Kirkcaldy Foodbank, Victoria Radio Network, Pete's Man Chat Movement, Fife Centre for Equalities and the Linton Lane Centre; notes that over £2,200 has been raised already in direct connection with the walk; pays credit to the incredible efforts of Kirkcaldy Strong founder Lisa May Young on organising and leading the event with the help of some fellow volunteers; thanks the local businesses who supported the initiative, including Cupcake Coffee Box, Fife Free Press, The Courier and Kingdom FM; and congratulates all who took part and helped to raise such valuable funds for these vital local charities supporting the Kirkcaldy community, particularly those who braved the heat in dinosaur and mascot costumes.

# 448 South Western Railway proposed timetable changes

That this House acknowledges the new timetable proposed by South Western Railway, due to come into effect in December 2022; laments that the proposed timetable amounts to a significant reduction in services; notes that current passenger behaviour is not yet representative of post-pandemic demand for public transport; further notes the importance of ensuring that service levels reflect post-pandemic passenger demand; recognises that accepted housing developments in areas near to potentially impacted rail stations have been designed in accordance with pre-pandemic service levels; further recognises South West Railway's analysis that leisure journeys will return to pre-pandemic levels; expresses concern that at this time of climate crisis, rail services are vital in reducing emissions from private vehicles; believes that announcements on proposed changes should be withheld to avoid incentivising commuters towards more polluting forms of transport; and calls on the Department for Transport to make the necessary interventions to protect heavily relied upon South Western Railway services.

#### 449 60 years of independent television in the north of Scotland

That this House is deeply concerned by the scale and severity of the covid-19 induced cancer backlog; notes Macmillan's estimate that it will take the NHS 18 months, working at 110 per cent capacity, to clear the cancer backlog; recognises that the UK has one of the lowest cancer survivability rates in international league tables; further recognises that radiotherapy is a covid-19 safe and economical cancer treatment, costing between £4,000 and £7,000 per patient; further notes the UK's historic underfunding of radiotherapy technologies and the woeful 27 per cent treatment rate for UK patients, in comparison to the international standard of 60 per cent; calls on the Government to support the recommendations of the APPG for Radiotherapy's 2021 Manifesto Update; and and urges that £865 million of the new multi-billion-pound NHS funding package is ringfenced for investments which improve radiotherapy services.

# 457 Arrests and detentions in the Kurdistan Region of Iraq

That this House notes with concern reports by Amnesty International and others that authorities in the Kurdistan Region of Iraq have subjected numerous journalists, activists and protestors to arbitrary arrests and forceable disappearances in a series of crackdowns beginning in March 2020; understands that among those detained is Sherwan Ameen, who graduated from the University of Glasgow's School of Education with a Master's in Teaching Adults in 2015, and who was among a number of teachers arrested for protesting that they had not been paid; further understands that he had been held without charge for almost a year until 6 September when he was charged with High Treason, which carries the death penalty, and that a trial has been set for October 6; calls on the Foreign Secretary to urgently raise this case and the wider situation with counterparts

in the Kurdistan Region of Iraq; and supports the calls of Amnesty International for an end to the crackdown on freedom of speech, the immediate release of all those who have been arbitrarily detained, and for the authorities to refrain from using vague and ill-defined laws to curtail the rights to freedom of expression and peaceful assembly in the region.

#### 458 Portadown Royal British Legion 100th Anniversary

#### 459 Mental health care

That this House believes there is a crisis of mental health problems in our country today; expresses its concern that the covid-19 outbreak has had a hugely detrimental impact on people's mental health, which is likely to lead to increased pressure on mental health services in the coming months and years; notes that there has been a 16 per cent increase in suicide since 2010; further notes that there are 2,120 fewer mental health nurses in England today than there were in 2010, 5,212 fewer mental health beds and that 695 people a month are having to travel outside of their area to access mental health services; acknowledges that these cuts have hit the North East and Yorkshire and the Humber particularly hard with a loss of a quarter of mental health beds since 2010, which has resulted in 150 people a month having to travel out of the area to receive treatment; recognises that the demand for mental health services currently far exceeds the provisions available; further believes that it is totally unacceptable that people who are struggling with mental health problems are unable to access the help they need; and demands that the Government immediately makes more funding available for mental health services.

#### 460 Eastbank Care Home awarded top twenty rated care homes in Scotland

#### 461 Life on the Breadline Report

That this House welcomes the publication of Life on the Breadline: Christianity, Poverty and Politics in the 21st Century City, researched and written by Dr Stephanie Denning, Dr Chris Shannahan, Professor Robert Beckford and Professor Peter Scott; notes that the research analyses the nature, reach and impact of Christian responses to austerity age poverty, providing insights into the impact of Christian engagement with poverty and raising new challenges for policymakers on responding to poverty in the UK; highlights the extent of the research for the report, which includes interviews with 16 national Church leaders and 104 regional Church leaders; emphasises the significance of the reports recommendations for tackling poverty, which stress the importance of Church leaders and policy makers working together to address the causes of poverty, alongside encouraging policymakers to spend more time with people experiencing poverty to understand the issue more deeply; and urges the Government to consider this report and to issue a response to the recommendations.

That this House notes with concern Ofgem's announcement of the £153 energy price cap rise due to take effect on 1 October 2021; further notes the rise will coincide with the end to the universal credit uplift and end to the Coronavirus Job Retention Scheme; regrets that these measures combined will further force 1.28 million more of those on low incomes into poverty; recognises that the energy and energy network companies' ability to realise significant profits from consumer bills since privatisation is evidence of a broken market; further recognises the pursual of fire and rehire tactics in private energy providers in the past year; acknowledges public support for public ownership in the energy system; believes that increased regulation and public ownership of private energy provision can deliver better investment in infrastructure, a faster switch to renewable energy, better staffing terms and conditions, and lower consumer bills; and further believes that public financial support for energy providers should come with clear conditions, including restrictions on elements of the private operating model such as dividend payments, excessive CEO remuneration, and with the option of public provision in the energy sector.
