223 Animal-free science and animal tests

That this House is concerned that the UK remains one of the countries in Europe consistently with one of the highest numbers of animal experiments, with over 2.88 million animals tests taking place in 2020 alone; is disappointed that UK legislation no longer contains a commitment to the final goal of full replacement of procedures on live animals found in recital 10 of Directive 2010/63/EU; acknowledges the ever-increasing capacity of animal-free, human relevant science to deliver economic and public health benefits as well as prevent animal suffering; notes that a recent YouGov survey found that 65 per cent of people want to see a Government-led, cross-departmental plan to incentivise an end to animal tests; further notes the Cruelty Free International campaign to Target Zero animal tests; and calls for a Minister with specific responsibility for providing strategic leadership to put in place a UK strategy to accelerate a transition to animal-free science.

224 OECD recommendations for SME and entrepreneurship policy

225 NICE guidelines on a digital therapeutic for insomnia

That this House welcomes new guidance MTG70 from the National Institute for Health and Care Excellence (NICE) on Sleepio, a digital therapeutic to treat insomnia and insomnia symptoms; understands that digital therapeutics are fully automated evidence-based treatments delivered in a digital format, designed to treat, manage, or prevent a medical condition; recognises this as a landmark moment for UK healthcare and innovation, with Sleepio the first-ever digital therapeutic to be evaluated by NICE; welcomes the rigour with which Sleepio was evaluated by NICE, with experts analysing Sleepio's 12 Randomised Controlled Trials and its independent health economics evaluation to ensure it is safe, effective and cost-effective before recommending its use; celebrates Sleepio as an example of UK innovation, with Sleepio's parent company Big Health founded by a Professor Colin Espie, a UK clinical psychologist and Professor of Sleep Medicine at University of Oxford, and Peter Hames, a former patient who experienced insomnia; recognises the role that innovation funding and support has played in generating evidence of Sleepio's impact, with NICE evaluating data from a large-scale project funded by Innovate UK and rolled out with the Oxford Academic Health and Science Network and NHS practitioners in the Thames Valley; recognises the patient impact Sleepio could have for the nearly one in three adults who experience insomnia symptoms each week, if made available via the NHS; and the importance of good sleep for mental health and wellbeing; and recognises the resource and cost savings Sleepio could deliver for the health and care system.

That this House celebrates the 74th anniversary of the arrival of HMT Empire Windrush at Tilbury Dock on the 22nd June 1948; recognises that Windrush has become a key symbolic moment in the history of both the Black British contribution to Britain and the broader post-war Commonwealth migration that reshaped the modern British society of today; acknowledges that this is not just Black history but it is British history; supports the celebrations taking place across the country that recognise the immense impact that the Windrush generation has had on the UK's society and culture since 1948; is ashamed by the Windrush scandal; condemns the suffering this has caused to members of the Windrush generation and their descendants, some of whom have been wrongfully deported, lost their homes and livelihoods and have been denied access to healthcare and public services; is outraged by the delays in the Windrush Compensation Scheme which led to at least 23 people passing away before receiving compensation; notes the conclusion of a leaked Home Office report that suggests the origins of the Windrush scandal lay in 30 years of racist immigration legislation designed to reduce the UK's non-white population; calls on the Home Office to release this report in full; notes that next year will mark the 75th anniversary of Windrush; and calls on this Government to mark the day with nationwide celebrations befitting of a day with such national importance.

Tabled: 21/06/22 Signatories: 7 safety and reduce deaths and serious injuries affecting the young on roads; highlights the 10,125 young people, under the age of 16, killed, seriously injured or slightly injured on roads in the UK in 2020, including 644 in Northern Ireland, despite the covid-19 outbreak reducing traffic and the fact that no level of casualties is acceptable; welcomes £2 billion investment into active travel schemes; congratulates Brake's Kids Walk on 22 June 2022 as a focus of community efforts to raise awareness; notes that over 90,000 schoolchildren from over 600 schools will be speaking out about road safety and the steps that can be taken to stop these avoidable tragedies affecting some of the most vulnerable in communities; further notes that on average six children are killed or seriously injured on UK roads every day; reiterates the WHO's findings that deaths from road traffic injuries are the single biggest killer of children and young people aged five to 29 globally and that exposure to air pollution, inclusive of vehicle emissions, is seriously damaging children's health; supports Brake's continuous drive to push for safer road journeys enabling children to walk in their community without fear of traffic and pollution; and urges the Government to implement statutory guidance for teaching road safety in UK schools so children can understand road danger and learn more.
