That this House declines to give a second reading to the Finance Bill because, notwithstanding the importance of increasing the energy (oil and gas) profits levy, it raises taxes on working people through its freeze of the personal allowance threshold; because it fails to take advantage of

other sources of revenue, such as ending non-domiciled tax status and further reducing the tax allowances available to oil and gas companies; and because it derives from an Autumn Statement which fails to set out plans to arrest the 7 per cent fall in average living standards forecast over the next two years, and to grow the UK economy, including through replacing business rates, supporting start-ups, giving businesses the flexibility they need to upskill their workforce, investing in clean and renewable energy, insulating homes across the country, and creating jobs in the green industries of the future.

That this House declines to give a Second Reading to the Finance Bill, because it is based on an Autumn Statement which failed to increase the Scottish Budget in line with inflation and to provide adequate support to those on low incomes, and because the Bill introduces a windfall tax which fails to include all companies

making excess profits and undermines investment in renewables technologies by applying the tax to electricity generators.
