The Lords have passed a Bill to make provision for the delivery of healthy homes and neighbourhoods; to set out the principles that define a “healthy home”; to establish the office of the Healthy Homes Commissioner; and for connected purposes, to which they desire the agreement of the Commons.

12 Government of Wales (Devolved Powers) Bill [Lords]

The Lords have passed a Bill to provide that powers devolved to Senedd Cymru must not be amended or withdrawn without a super-majority vote of its elected members; and for connected purposes, to which they desire the agreement of the Commons.

13 Protection from Redundancy (Pregnancy and Family Leave) Bill

Because it is consequential on Lords Amendment 5 to which the Commons disagree.

Because it is consequential on Lords Amendment 5 to which the Commons disagree.
