TUESDAY 7 NOVEMBER 2023

The State Opening of Parliament will take place. The House will meet at 11.25am for the King's Speech. Members may follow the Speaker and party leaders to hear the speech delivered in the Lords. Afterwards the House will suspend until 2.30pm.

After introductory statements by the Speaker, the Outlawries Bill will receive its first reading. This is a purely formal proceeding whereby the House asserts its right to deliberate on matters of its own choosing before those proposed by the Government in the King's Speech: no Bill is produced nor is there any debate. The debate on the King's Speech is then opened. Two backbench Members from the Government side will propose and second a motion for an Address (thanking the King for the Speech), after which the Leader of the Opposition and the Prime Minister will speak. Debate on the King's Speech may continue until 10.00pm on this day and will be resumed on subsequent days. The debate normally lasts for six sitting days: the Speaker will announce at the start of the debate which subjects are to be the main subject of debate on each day.

SUBSEQUENT DAYS

Debate on the King's Speech will be resumed on subsequent days. On the final day of the debate the House votes on the motion, and there may be votes on amendments to the motion on the penultimate and final days.

Applications for adjournment debates: Tuesday 14 November to Monday 20 November (deadline Wednesday 8 November 7.00pm or the rise of the House, whichever is earlier)

Applications should be made on MemberHub or in writing to the Table Office. Emailed applications must be submitted from a Member's own email account. Application forms are available on the Table Office page on the Parliamentary intranet. The ballot will take place on Thursday 9 November.

FORTHCOMING WESTMINSTER HALL DEBATES

There will be no Westminster Hall debates in the new Session of Parliament until the debate on the King's Speech has concluded (Standing Order No. 10(2)(a)). The new rota for answering Departments will be published in the Order Paper as soon as it is available, and Members will be able to submit applications when that rota is published.

QUESTIONS AND AMENDMENTS

The e-tabling function on MemberHub will be closed for maintenance between sessions and is expected to be restored on the day after Parliament prorogues. All Questions and motions fall at Prorogation and Questions from the 2022-23 Session will not be saved on MemberHub. Questions cannot be answered during Prorogation and Questions that have not received an answer can be tabled in the new Session. They will not be re-tabled automatically.

Any Questions received during Prorogation (through MemberHub once it reopens) will be treated as having been received on Tuesday 7 November. Members may table a maximum of five Named Day Questions during the period between prorogation and the rise of the House on Tuesday 7 November.

The Table Office will be providing its usual services from 10.00am on Tuesday 7 November. The earliest date for which a Question may be set down for named day written answer will be Monday 13 November. There will be no Question Time on the first three sitting days of the new Session. Amendments to the Motion for an Address may be tabled as soon as the Member seconding the Address has sat down, and will be placed on the Order Paper in the order in which cleared texts are received. Amendments may be pre-cleared with the Table Office. The deadline for tabling amendments will be the rise of the House each day. The final deadline will be rise of the House on the penultimate day of debate (expected to be Tuesday 14 November).

Members may table amendments in hard copy or by email; Member's staff may table hard copies if signed by the Member. In the event of a timing clash, hard copy will take precedence

TABLING MOTIONS FOR THE NEW SESSION

New Early Day Motions (EDMs) can formally be submitted in the new Session from 10.00am on Tuesday 7 November. Proposed EDMs may be entered on to the MemberHub system before then, as the system will be operational from the day after Parliament prorogues. However, for the purposes of numbering of EDMs in the new Session, the first EDMs to be processed (and numbered EDM 1 etc) will be those submitted in hard copy to the Table Office between 10.00am and 3.00pm on 7 November, in the order in which they are received. Proposed EDMs submitted in advance on the MemberHub system can be added to the list of first EDMs if an additional hard copy is received with that request at or after 10.00am on 7 November. EDMs emailed before 10.00am on 7 November will be processed after those arriving between 10.00am and 3.00pm for the purposes of numbering, followed by those only submitted on MemberHub.
