obligations; to make provision for retrospective parliamentary approval in certain circumstances; and for connected purposes.

Bill read the first time; to be read a second time on Friday 26 January, and to be printed (Bill 146).

8 Scotland (Self-Determination): Motion for leave to bring in a Bill (Standing Order No. 23)

Motion made and Question proposed, That leave be given to bring in a Bill to amend the Scotland Act 1998 to transfer the power to legislate for a Scottish independence referendum to the Scottish Parliament; to provide that that power may only be exercised where the Scottish public has demonstrated its support for the holding of such a referendum; to provide that no such referendum may be held sooner than seven years after the previous such referendum; and for connected purposes.—(*Neale Hanvey.*)
