### **11 Safety of Rwanda (Asylum and Immigration) Bill: Reasons Committee**

Michael Tomlinson reported that the Committee had agreed the following Reasons:

#### **Lords Amendment 1B**

Because the Commons consider that the provisions of the Bill are compliant with domestic and international obligations, and that it is therefore not necessary to refer expressly to having due regard for domestic and international law when setting out the purpose of the Bill.

#### **Lords Amendments 3B and 3C**

Because the Commons consider that it is not necessary to refer expressly to the arrangements in the Rwanda Treaty being, and continuing to be, implemented and adhered to; the Bill is clear that it comes into force on the day on which the Rwanda Treaty enters into force and it is not appropriate for the Bill to legislate for Rwanda adhering to its obligations under

the Treaty as Rwanda's ongoing adherence to its Treaty obligations will be subject to the monitoring provisions set out in the Treaty.

#### Lords Amendment 6B

Because the Commons consider that it is not appropriate to leave out clause 4 of the Bill and insert the new clause in the Amendment, as the Bill allows decision-makers to consider claims that Rwanda is unsafe for an individual due to their particular circumstances.

#### Lords Amendment 7B

Because the Commons consider that it is not appropriate to amend the age assessment provisions of existing legislation.

#### Lords Amendment 10B

Because the Commons consider that it is not necessary as the only way individuals should come to the UK is through safe and legal routes.
