Seamus Logan, supported by Stephen Flynn, Pete Wishart, Kirsty Blackman, Dave Doogan, Stephen Gethins, Chris Law, Graham Leadbitter, Brendan O'Hara, Claire Hanna and Ben Lake, presented a Bill to

exclude requirements relating to National Health Services procurement, delivery or commissioning from international trade agreements; to require the consent of the House of Commons and the devolved legislatures to international trade agreements insofar as they relate to the National Health Services of England, Scotland and Wales and Health and Social Care in Northern Ireland; and for connected purposes.

Bill read the first time; to be read a second time on Friday 17 January 2025, and to be printed (Bill 109).

#### **4 Vehicle Registration Documents (Sale of Vehicle) Bill: Presentation (Standing Order No. 57)**

Mr Richard Holden presented a Bill to require a seller of a vehicle to record their home address or specified information about a company that owns the vehicle in the vehicle's registration document; and for connected purposes.

Bill read the first time; to be read a second time on Friday 28 March 2025, and to be printed (Bill 107).

## **5 Dogs (Protection of Livestock) (Amendment) (No. 2) Bill: Presentation (Standing Order No. 57)**

Joe Morris presented a Bill to make provision changing the law about the offence of livestock worrying, including changes to what constitutes an offence and increased powers for investigation of suspected offences; and for connected purposes.

Bill read the first time; to be read a second time on Friday 25 April 2025, and to be printed (Bill 52).

## **6 Commonwealth Parliamentary Association and International Committee of the Red Cross (Status) Bill [Lords]: Second Reading**

Bill read a second time.

## **7 Commonwealth Parliamentary Association and International Committee of the Red Cross (Status) Bill [Lords]: Programme**

Motion made and Question put forthwith (Standing Order No. 83A(7)), That the following provisions shall apply to the Commonwealth Parliamentary Association

and International Committee of the Red Cross (Status) Bill [Lords]:

*Committal*

(1) The Bill shall be committed to a Public Bill Committee.

*Proceedings in Public Bill Committee*

(2) Proceedings in the Public Bill Committee shall (so far as not previously concluded) be brought to a conclusion on Wednesday 13 November 2024.

(3) The Public Bill Committee shall have leave to sit twice on the first day on which it meets.

*Consideration and Third Reading*

(4) Proceedings on Consideration shall (so far as not previously concluded) be brought to a conclusion one hour before the moment of interruption on the day on which those proceedings are commenced.

(5) Proceedings on Third Reading shall (so far as not previously concluded) be brought to a conclusion at the moment of interruption on that day.

(6) Standing Order No. 83B (Programming committees) shall not apply to proceedings on Consideration and Third Reading.

*Other proceedings*

(7) Any other proceedings on the Bill may be programmed.—(*Christian Wakeford.*)

Question agreed to.

## **8 Commonwealth Parliamentary Association and International Committee of the Red Cross (Status) Bill [Lords]: Money**

King's Recommendation signified.

Motion made and Question put forthwith (Standing Order No. 52(1)(a)), That, for the purposes of any Act resulting from the Commonwealth Parliamentary Association and International Committee of the Red Cross (Status) Bill [Lords], it is expedient to authorise the payment out of money provided by Parliament of any amount refunded in respect of any tax or duty in accordance with arrangements made under the Act.—(*Christian Wakeford.*)
