Secretary Wes Streeting, supported by the Chancellor of the Exchequer, Secretary Yvette Cooper, Secretary Shabana Mahmood, Secretary Jonathan Reynolds, Secretary Hilary Benn, Secretary Ian Murray, Secretary Bridget Phillipson, Secretary Jo Stevens, Secretary Steve Reed and Andrew Gwynne, presented a Bill to make provision about the supply of tobacco, vapes and

other products, including provision prohibiting the sale of tobacco to people born on or after 1 January 2009 and provision about the licensing of retail sales and the registration of retailers; to enable product and information requirements to be imposed in connection with tobacco, vapes and other products; to control the advertising and promotion of tobacco, vapes and other products; and to make provision about smoke-free places, vape-free places and heated tobacco-free places.

Bill read the first time; to be read a second time tomorrow, and to be printed (Bill 121) with Explanatory Notes (Bill 121–EN).

4 Poly and perfluorinated alkyl substances (guidance): Motion for leave to bring in a Bill (Standing Order No. 23)

Ordered, That leave be given to bring in a Bill to require the Chief Inspector of Drinking Water to issue guidance to water companies on poly and perfluorinated alkyl substances in drinking water; and for connected purposes;

That Munira Wilson, Tim Farron, Alex Sobel, James MacCleary, Alberto Costa, Edward

Morello, Ellie Chowns, Sarah Olney, Ruth Cadbury, David Chadwick, Cameron Thomas and Mr Joshua Reynolds present the Bill.

Munira Wilson accordingly presented the Bill.

Bill read the first time; to be read a second time on Friday 24 January 2025, and to be printed (Bill 120).
