*Ordered,* That leave be given to bring in a Bill to make provision about the liability of practitioners, and of the organisation which employs the practitioner, where

a practitioner prescribes an unlicensed medicine to or carries out a non-standard treatment on a person who is terminally ill; to make provision about the import, storage and use of equipment and unlicensed medicines for the purpose of such prescriptions or such treatment; and for connected purposes;

That Dame Siobhain McDonagh, Jim Shannon, Uma Kumaran, Peter Lamb, Luke Murphy, Rachael Maskell, Tonia Antoniazzi, Valerie Vaz, Mary Glindon, SORCHA Eastwood, Helena Dollimore and Natasha Irons present the Bill.

Dame Siobhain McDonagh accordingly presented the Bill.

Bill read the first time; to be read a second time on Friday 17 January 2025, and to be printed (Bill 139).

(2) Proceedings in the Public Bill Committee shall (so far as not previously concluded) be brought to a conclusion on Thursday 30 January 2025.

(3) The Public Bill Committee shall have leave to sit twice on the first day on which it meets.

### *Consideration and Third Reading*

(4) Proceedings on Consideration shall (so far as not previously concluded) be brought to a conclusion one hour before the moment of interruption on the day on which those proceedings are commenced.

(5) Proceedings on Third Reading shall (so far as not previously concluded) be brought to a conclusion at the moment of interruption on that day.

(6) Standing Order No. 83B (Programming committees) shall not apply to proceedings on Consideration and Third Reading.

### *Other proceedings*

(7) Any other proceedings on the Bill may be programmed.—(*Chris Elmore.*)

Question agreed to.

## **6 Tobacco and Vapes Bill: Money**

(2) any increase attributable to the Act in the sums payable under or by virtue of any other Act out of money so provided.—(*Chris Elmore.*)
