Motion opposed (Standing Order No. 23(1)).

That Sarah Olney, Wendy Chamberlain, David Chadwick, Sorcha Eastwood, Marie Goldman, Richard Foord, Tim Farron, Ed Davey, Christine Jardine, Dr Al Pinkerton and Daisy Cooper present the Bill.

Sarah Olney accordingly presented the Bill.

Bill read the first time; to be read a second time on Friday 24 January 2025, and to be printed (Bill 138).

6 National Insurance Contributions (Secondary Class 1 Contributions) Bill: Second Reading

Motion made and Question proposed,
That the National Insurance Contributions (Secondary Class 1 Contributions) Bill be now read a second time.

Amendment proposed, to leave out from 'That' to the end of the Question and add 'this House declines to give a Second Reading to the National Insurance Contributions (Secondary Class 1 Contributions) Bill because it breaks the manifesto commitment of the Labour Party not to increase National Insurance; and will lead to lower growth, lower wages for

working people, fewer jobs and the closure of businesses.'.—(*Richard Fuller.*)

The Deputy Speaker announced a time limit on backbench speeches (Standing Order No. 47(1)).

Question put, That the Amendment be made.

Committal

(1) The Bill shall be committed to a Committee of the whole House.

Proceedings in Committee, on Consideration and on Third Reading

(2) Proceedings in Committee shall (so far as not previously concluded) be brought to a conclusion four hours after their commencement.

(3) Any proceedings on Consideration and proceedings on Third Reading shall (so far as not previously concluded) be brought to a conclusion five hours after

the commencement of proceedings in Committee of the whole House.

(4) Standing Order No. 83B (Programming committees) shall not apply to proceedings in Committee of the whole House, to any proceedings on Consideration or to proceedings on Third Reading.

(5) Any other proceedings on the Bill may be programmed.—(*Jeff Smith.*)

Question agreed to.

8 National Insurance Contributions (Secondary Class 1 Contributions) Bill: Money

King's Recommendation signified.

Motion made and Question put forthwith (Standing Order No. 52(1)(a)), That for the purposes of any Act resulting from the National Insurance Contributions (Secondary Class 1 Contributions) Bill, it is expedient to authorise the payment out of money provided by Parliament of any increase in the sums payable under any other Act out of money so provided that is attributable to—

(a) increasing the employment allowance for a tax year to an amount not exceeding £10,500, and

(b) the repeal of subsections (4B) to (4G) of section 2 of the National Insurance Contributions Act 2014.—(*Jeff Smith.*)

Question agreed to.
