Secretary Yvette Cooper, supported by the Prime Minister, the Chancellor of the Exchequer, Secretary Shabana Mahmood, Secretary Steve Reed, the Solicitor General and Dame Diana Johnson, presented a Bill to make provision about anti-social behaviour, offensive weapons, offences against people (including sexual offences), property offences, the criminal exploitation of persons, sex offenders, stalking and public order; to make provision about powers of the police, the border force and other similar persons; to make provision about confiscation; to make provision about the police; to make provision about terrorism and national security, and about international agreements relating to crime; to make provision about the criminal liability of bodies; and for connected purposes.

Bill read the first time; to be read a second time tomorrow, and to be printed (Bill 187) with Explanatory Notes (Bill 187–EN).

5 River Wye (cleaning): Motion for leave to bring in a Bill (Standing Order No. 23)

Ordered, That leave be given to bring in a Bill to require the Secretary of State to publish and implement a plan for cleaning and improving the water quality of the River Wye; and for connected purposes;

That Jesse Norman and Ellie Chowns present the Bill.

Jesse Norman accordingly presented the Bill.

Bill read the first time; to be read a second time on Friday 4 July, and to be printed (Bill 186).

Institute for Apprenticeships and Technical Education (Transfer of Functions etc) Bill [Lords]: Second Reading

Motion made and Question proposed, That the Institute for Apprenticeships and Technical Education (Transfer of Functions etc) Bill [Lords] be now read a second time.

Amendment proposed, to leave out from 'That' to the end of the Question and add 'this House declines to give a Second Reading to the Institute for Apprenticeships and Technical Education (Transfer of Functions etc) Bill because, while acknowledging the importance of reforming the delivery of skills and technical education, it fails to establish Skills England as a statutory independent body; because it centralises decision-making power in the hands of the Secretary of State; because it provides for the abolition of the Institute for Apprenticeships and Technical Education without ensuring a legally defined replacement; and because it lacks provisions to ensure that Skills England is directly accountable to Parliament.'.—(Ian Sollom.)

Question put, That the Amendment be made.
