That title, and associated text, had been substituted in error for the Arm's-Length Bodies (Review) Bill. As the House had been notified, the Arm's-Length Bodies (Review) Bill had not been correctly printed at that time, which was a requirement under Standing Order No. 14(3). The order for second reading therefore lapsed at the rising of the House on 13 March.

Once the Bill had been printed and made available in the Vote Office, notice could be given appointing the next available Private Members' Bill Friday for second reading and

so all subsequent proceedings, including on 28 March and today, were unaffected.
