That this House recognises that the Conservative Party stands by the result of the 2016 referendum to leave the European Union (EU); calls on the Government to stand by that decision at the summit with the EU on 19 May 2025, to put the national interest first and not to row back on Brexit, for example by re-introducing free movement through a EU youth mobility scheme, accepting compulsory asylum transfers, creating dynamic alignment between the UK and the EU, by submitting the UK to further oversight from the European Court of Justice or by joining the EU's carbon tax scheme which will lead to higher energy bills; further

calls on the Government to stand by the will of the British people by ensuring that no new money is paid to the EU, that there is no reduction in UK fishing rights, that NATO remains the foundation of European security and that the UK can continue to undertake strategic and defence agreements with non-EU partners; and also calls on the Government to put the negotiated outcome to a vote in the House of Commons.
