That this House, while acknowledging the need to establish an arm's-length body to oversee rail operations and connect track and train after the previous Government promised but failed to deliver Great British Railways, declines to give a Second Reading to the Railways Bill because it does not put passengers or freight users at the heart of decision making; because it fails to implement a long term plan to build back revenue to meet goals for the environment and growth and bring value for passengers; it fails to make fares more affordable or services more reliable; it provides no guarantee that new stations, lines and services will open; it does not promote on-rail competition between operators or competitive tendering to increase services, deliver newer trains, grow passenger numbers and reduce subsidies; it continues the overly centralised governance of the railway championed by the previous Government, which ultimately failed to improve services; and therefore will not result in the reinvigoration of Britain's railways that the country needs and passengers deserve.

That this House declines to give a Second Reading to the Railways Bill because it prioritises putting the rail system under state control, rather than prioritising passengers and taxpayers, and the effective and efficient running of the railway; because it significantly reduces the role of the independent regulator, the Office of Rail and Road, whose duties it transfers in large part to Great British Railways, with limited rights of appeal against Great British Railways' decisions, so there will be no proper accountability for the state controlled operator, and this, along with the duty for Great British Railways to prioritise its own services for access to track, will squeeze out popular and wellregarded open access operators, who run services without taxpayer subsidy; because it allows ministers to interfere at will in the running of the railways, for example by setting fares, which will not create a stable environment for private sector investment, with the result that reliance on taxpayer subsidy will increase; and because it will do nothing to grow passenger numbers, or modernise or improve the rail network, and does not include provisions to grow rail freight, which means that the chance to create a thriving railway which delivers economic growth and relies less on taxpayer support will be lost.

- 6. Standing Order No. 83B (Programming committees) shall not apply to proceedings on Consideration and Third Reading.

7. Any other proceedings on the Bill may be programmed.
